Subject: Authorization to operate the budget heads for releasing funds relating to Textile Labour Rehabilitation Scheme (TLRS) during 2016-17 – reg.

Madam,

I am directed to convey the sanction of the President of India to authorize the Textile Commissioner, Mumbai to operate the budget heads as mentioned below for incurring an expenditure upto Rs. 5,00,00,000/- (Rupees Five crores only), for the Textile Labour Rehabilitation Scheme (TLRS) for the year 2016-17, subject to following conditions:-

- i. No UC is pending against the Implementing Agency of the scheme in Ministry of Textile and its subordinate office.
- ii. Fund released will be utilized on approved eligible components within component-wise ceiling in accordance with scheme guidelines.
- iii. Financial assistance under the scheme is provided to only eligible beneficiaries as per the scheme.
- iv. O/o the TxC may certify that the beneficiaries of the scheme have not availed similar financial assistance from any other central/State/ Government/ Non-Government organization.
- v. The financial assistance to the beneficiaries is released as per the quantum and period prescribed in the approved scheme guidelines.
- vi. Payment of financial assistance to the beneficiaries under the scheme may be linked to the Aadhar Card.
- vii. As every beneficiary is required to open a 'Savings Bank Account', financial benefit to all beneficiaries may be credited to their respective savings account through Electronic Clearing System (ECS).
- viii. O/o the TxC may certify that financial relief under the scheme is provided to a beneficiary for three years on a tapering basis and will not be extended beyond the date of superannuation of any worker. A certification to this effect may also be obtained from the O/o the TxC in respect of the claims already settled.
- ix. Keeping in view the quantum of release under the scheme till date, it is advised that the relevant accounts of the 'Implementing Agency' may be audited by the C&AG before releasing further funds under the scheme.
- x. Financial assistance will be disbursed to end-beneficiary on certification that he is not employed any where at the time of grant of assistance.

- 2. The amount will be disbursed by the various offices of the Textile Commissioner as per the guidelines of the Scheme. The Office of the Textile Commissioner will submit monthly report to the Ministry on regular basis about the details of the actual disbursement made.
- 3. The expenditure is debitable to the Budget Head Major Head, "2852"- Industries 08 Consumer Industries 202 Textiles 07 Textile Labour Rehabilitation Scheme 07.00.50- Other charges (Non-Plan) under Demand No. 87 for the financial year 2016-17.
