Record Note of Discussion of the First Meeting of ESG Task Force held on 22.08.2023

In pursuance of the announcement made by the Hon'ble Minister of Textiles on 22.04.2023 at the Tamil Saurashtra Sangamam in Rajkot, an ESG Task Force chaired by the Additional Secretary, Ministry of Textiles was constituted for engaging in deliberations with stakeholders of the textile and apparel industry in ascertaining the current status and issues in transitioning the textile industry to a sustainable and resource-efficient production system.

- 2. The first meeting of the Task Force was held on 22.08.2023 in Room No.47, Udyog Bhawan, New Delhi. The list of participants is in **Annexure I**.
- 3. At the outset, a warm welcome was extended to all the participants. Smt. Prajakta L. Verma, Joint Secretary, Ministry of Textiles set the context for the meeting and laid impetus on the need for collaboration to harness the strength of different stakeholders for meeting the new requirements and standards for achieving global competitiveness. This platform has been formed to highlight the ground reality and challenges of the MSMEs and the industry and use the forum to design a graded approach to overcome these challenges.
- 4. The chairperson in his opening remarks emphasized that the Task Force will not be a prescriptive forum but rather a deliberative forum where the entire value chain can work collaboratively. He urged the active participation of all the stakeholders to make this a holistic outcome-based group.
- 5. Subsequently, detailed presentations were made by the Bureau of Energy Efficiency (BEE), Sattva Consulting, and KPMG on various aspects relating to ESG requirements (Annexure-II). The first presentation was made by the Bureau of Energy Efficiency on the PAT (Perform-Achieve-Trade) Scheme for the Textile Sector for decarbonization and climate change mitigation. He highlighted that the textile sector was the second highest contributor to emissions intensity per unit among the PAT sectors, second only to Aluminum. A background on PAT was given by Mr Ashok Kumar, DDG, BEE. He informed that the PAT scheme, under the National Mission for Enhanced Energy Efficiency, recognizes industries with a threshold energy consumption, and energy efficiency improvement targets are given to designated consumers (DCs) who have an annual energy consumption of 3000 TOE (tonnes of oil equivalent). The current PAT Cycle overview was given by Mr Ajitesh Upadhyay, Senior Sector Expert (PAT), and emission reduction interventions so far were shared.
- 6. The second presentation was made by Sattva Consulting on ESG Integration in Textiles and Apparel MSMEs. Ms Mansha Balecha discussed the increasing downstream pressure on MSMEs and the need to integrate ESG and sustainable practices among MSMEs. They further highlighted five key challenges they faced: a lack of ESG/ Sustainability knowledge and awareness, lack of adequate capability and capacity, cost constraints, lack of standardization in buyer demands, and fear of certifications. Smt. Prajakta L. Verma, Joint Secretary, seconded the point about certifications and MSMEs' desire to transition to the path of sustainability but are hindered by the jungle of certifications that prevents the adoption. She also highlighted the need for hand-holding to build the capacities of the MSMEs. Mr Rahul Mehta, Chief Mentor, CMAI suggested a collaboration between Sattva and CMAI to increase the sample size and improve the representation of MSMEs in the study for a truer picture of the sector. Suggestions for skilling centers in remote areas to improve the availability of skilled workforce were made by SGCCI.
- 7. Shri Mohit Bhasin, KPMG made a presentation on Export Competitiveness and International ESG Requirements for the Textiles Sector. He explained the various markers and aspects of the textile value chain that will impact global competitiveness and how India is performing on these parameters. ESG accounting, although, currently limited to listed textile companies in India will trickle down to smalles industries due to increased pressure from the EU. He then elaborated on the success stories of Bangladesh and Vietnam in the textile sector

and laid impetus on the need for a Mission for Sustainable Textiles because of the need for inter-ministerial dependency in sustainability. Mapping of existing leading practices and convergence of stakeholders can improve the adoption of these compliance measures.

- 8. The floor was then opened to all the stakeholders for their input and suggestions. Mr. Anil Jain from FICCI suggested that the industry needed knowledge of Carbon Markets. A suggestion was made to start a mission on sustainable textiles with brand participation in capacity building. BEE and CITI laid emphasis on the need for a knowledge repository and a data-capturing format/framework. SU.RE Alliance also recommended the need for an SOP/roadmap for information to trickle down to smaller units and build on peer learning. IDH also recommended forming a common network on platforms like LinkedIn for regular information sharing and dissemination.
- 9. The Joint Secretary summarised the meeting and appealed to the stakeholders to work together in a cohesive, outcome-driven manner.
- 10. In his concluding remarks, the Chairperson thanked the stakeholders for their participation and appreciated their active involvement in the deliberations. He reiterated the need for the creation of sub-groups for collating and disseminating the existing Standards /Certification, leading practices, and the challenges faced by MSMEs in adopting the standards and recommendations. The Chairperson also indicated that the Task Force will meet periodically with a defined agenda and ensure an inclusive participation of stakeholders.
- 11. The Task Force after detailed deliberations resolved to work towards the following action points:
 - 1. Office of the Textiles Commissioner to work collaboratively with BEE and proactively identify the units to be registered under the PAT scheme
 - 2. Identify the need for capacity building and strengthening the institutional capacity of organizations to engage with MSMEs to improve their market competitiveness
 - 3. Create sub-groups for deliberations on specific ToRs & action points
 - 4. Identify and maximize industry participation in inter-ministerial schemes that promote sustainability to ensure any bottlenecks in availing benefits under the said scheme are addressed
 - 5. Develop a repository of industry initiatives, best practices, and case studies for easy access to MSMEs
 - 6. Collaborate with industry association(s) to identify areas for seeking technical and financial assistance
 - 7. Develop an eco-system for hand-holding at the cluster level to promote sustainable and circular practices

The meeting ended with a vote of thanks to the Chair and participants.
