



**Subject: Quality Control Mechanism for PPE Body Coveralls
Manufactured in India - reg.**

Ref: Ministry of Textile's letter of even number dated 06.04.2020.

With a view to streamline the process of testing of and ensure that the quality of the PPE Coveralls are maintained, it is proposed to further elaborate the test and certification procedure as per following:-

- (i) The Testing Laboratory will accept the sample only on submission of a Notarised Affidavit by the authorized signatory of the organisation, intending to get their PPE Coverall sample(s) tested in the approved laboratories, as per the prescribed format (enclosed). The test samples are to be accepted for testing, only after ascertaining that the declaration form is duly filled up and received through the official e-mail id. The Affidavit is to be submitted in original along with the test sample, and also a scanned copy be sent to the laboratory e-mail id. The Certificate will be sent in the e-mail id from which the request was obtained.
- (ii) The UCC (Unique Certification Code) should now form the basis for placement of orders by M/s HLL Lifecare for PPE Coveralls. The Test Report is to be Annexed to the UCC only. The Declaration Form should be scanned and facsimiled to the body of the UCC itself for sake of transparency. The Certificate should be page numbered and signed by the authorized laboratory official on all pages.
- (iii) All UCCs issued so far, since March 2020, may be modified in the new format in respect of both (already certified as well as the prospective manufacturers). For this purpose, it may be informed to the already certified manufacturers that the UCC issued to them earlier is valid up to a certain period (say 5th May 2020) and fresh UCC will be valid from the new date. THE UCC may have a validity period of 6 months only from the date of issue.



- (iv) The details of the Unique Certification Code (UCC) issued in the revised format may be published on the official website of the testing and certifying organisation. A link may be provided against each UCC for the viewer to be able to access the Certificate. The link may also be mentioned on the body of the certificate itself.
- (v) The testing laboratory may is responsible for the integrity of the prototype sample submitted by the applicant. It is the responsibility of the procuring organization to complete its due diligence process before placement of the supply agreement. This may be stated in the Certificate.
- (vi) M/s HLL Lifecare is requested to take into cognizance the UCCs issued and sent to the official e-mail id of the designated official of HLL, directly from the testing laboratory only.
- (vii) Until such time the lock down is in force, the Declaration may be made in a plane paper attested by the Notary Public. In such cases, the Certificate may be issued provisionally valid for one month time. On submission of the Notarized affidavit only, the Certificate may be made regular.

2. The provisions stated above may be made effective, at the earliest under intimation to the Ministry.
